WHAT WILL YOU NEED FROM ME?

Fill out this form, print it, and bring it to one of our branch locations listed below. We will also need for you to bring the following:

- 2 forms of ID (Gov't-issued photo id -DL, State ID, Passport, etc.,-and one more form such as SSN card, official mail, birth certificate, insurance card. (Reminder: Please remember to bring children's social security card and birth certificate with you when opening children's accounts.)
- Proof of physical address.
 - o If provided forms of ID do not list physical address, or if it is a brand new address, we will need to see car registration, any official mail, something that is printed with the physical address. (A Secretary of State update sticker on your license is perfectly acceptable.)
- If you work, worship or go to school in one of our eligible counties, we must have a letter from that organization, a paystub, or something to establish proof of the relationship.
- A \$5.00 minimum deposit establishes your Regular Share (Savings) Account. This Regular Share (Savings) Account is required for access to all other services provided by the Credit Union. The \$5.00 minimum deposit must remain in the account as long as you are a member of, and wish to use services provided by, Wexford Community Credit Union.
